\$50,000 Added**

FOR COLTS AND GELDINGS, TWO YEARS OLD (FOALED IN 2015) Eligibles must be registered with the Illinois Department of Agriculture as Illinois Conceived and Foaled or Illinois Foaled Thoroughbreds. By subscription of \$25 each horse made on or before August 31, 2016 (fee to accompany nomination). To remain eligible the following payments must be made: \$50 each on or before April 10, 2017. \$75 each on or before August 31, 2017. If the \$25 nomination fee is not made in a timely manner, a late nomination fee of \$200 must accompany the \$50 April 10, 2017 payment. Nominees to pay \$250 each to pass the entry box, \$250 each additional to start. With \$50,000 Added from the Illinois Thoroughbred Breeders Fund and the appropriate purse account to be divided 60 percent to first; 20 percent to second; 11 percent to third; 6 percent to fourth; 3 percent to fifth. Weight; 122 lbs. Non-winners of \$25,000 at a mile or over allowed, 2 lbs.; at any distance, 4 lbs.; a race other than maiden claiming or starter, 6 lbs.; maidens, 8 lbs. This race will be limited to fourteen starters. Preference will be (1st) winners; (2nd) horses with the highest lifetime earnings. Failure to draw into the race will cancel entry fees only. Starters to be named through the entry box by the usual time of closing. Trophy to breeder and owner of the winner.
